Highlights in the quarter

Fourth quarter of 2024 (Q4 2023)

- Total operating revenues increased by 31.5% to EUR 625.3 million (475.3)
 - Net revenues increased by 12.3% to EUR 533.8 million (475.3)
 - Live growth +13.3% to 459.5MEUR (405.6)
 - RNG growth +6.7% to 74.4 MEUR (69.8)
 - Other operating revenues (related to reduced earn-out liability) EUR 91.4 million (0)
- EBITDA increased by 35.0% to EUR 455.0 million (337.0), corresponding to a margin of 72.8% (70.9)
- Adjusted EBITDA (excluding other operating revenues) increased by 7.9% to EUR 363.6 million (337.0), corresponding to a margin of 68.1% (70.9)

January-December 2024 (4Q 2023)

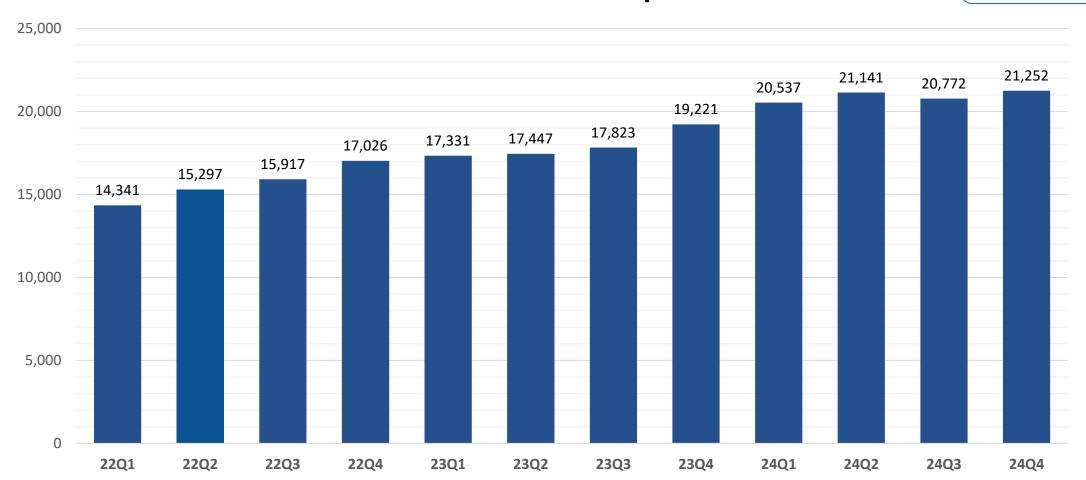
- Total operating revenues increased by 23.1% to EUR 2,214.1 million (1,798.6)
 - Net revenues increased by 14.7% to EUR 2,063.1 million (1,798.6)
 - Live growth +16.6% to 1,775.7 EUR (1,523.3)
 - RNG growth +4.4% to 287.4 MEUR (275.3)
 - Other operating revenues (related to reduced earnout liability) EUR 151.1 million (0)
- EBITDA increased by 23.2% to EUR 1,561.8 million (1,267.4), corresponding to a margin of 70.5% (70.5)
- Adjusted EBITDA (excluding other operating revenues) increased by 11.3% to EUR 1,410.7 million (1,267.4), corresponding to a margin of 68.4% (70.5)

Headcount end of period

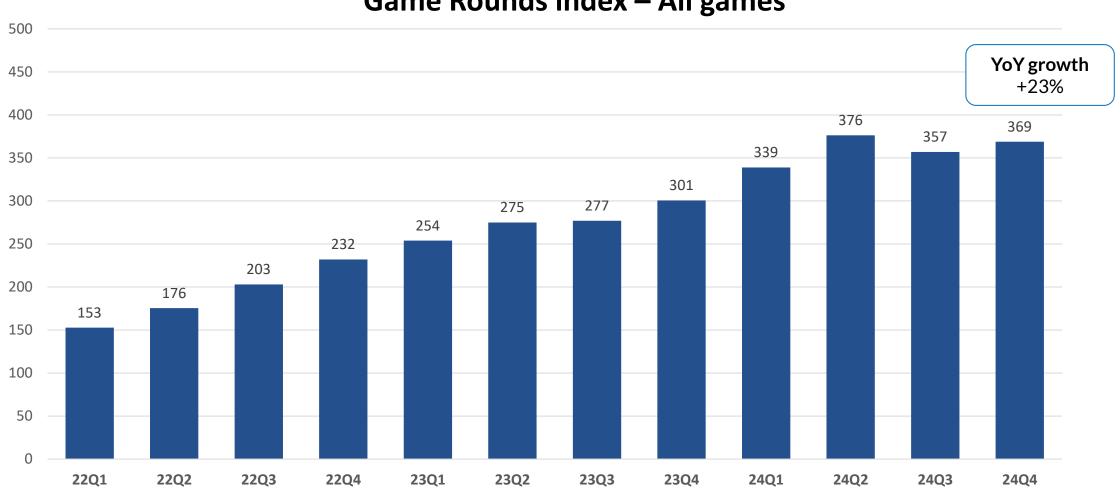

Game Rounds index – All games













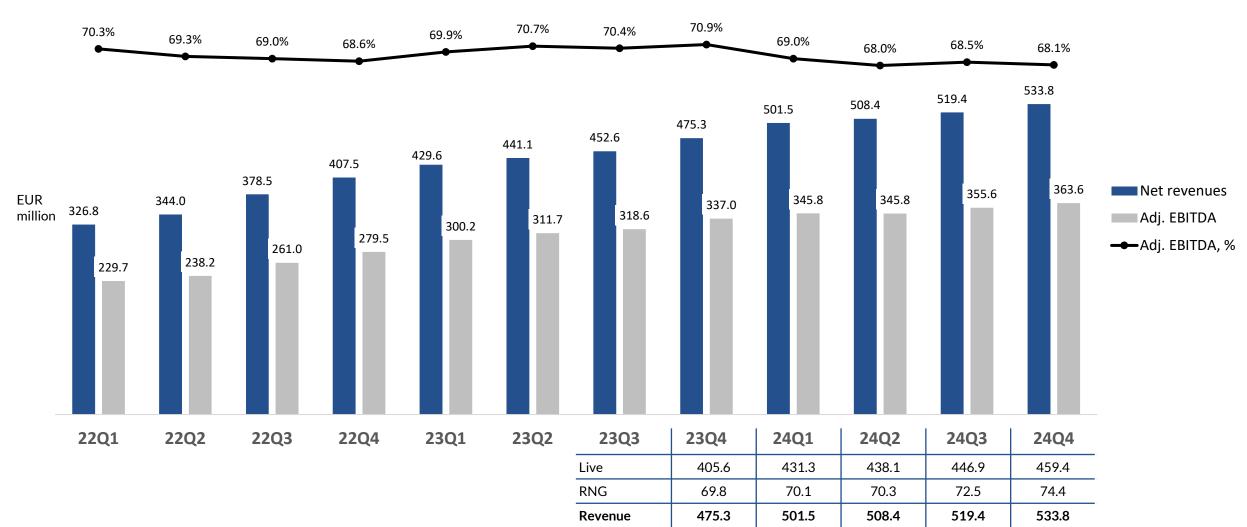

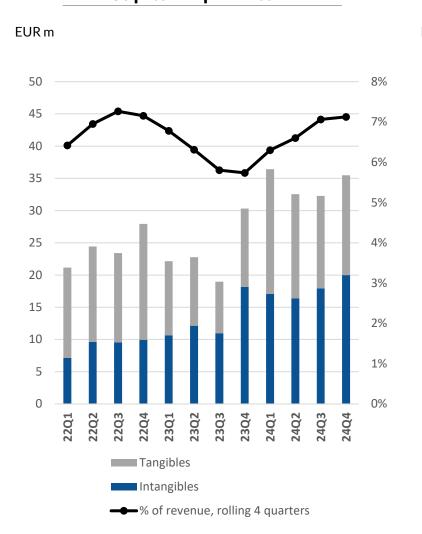


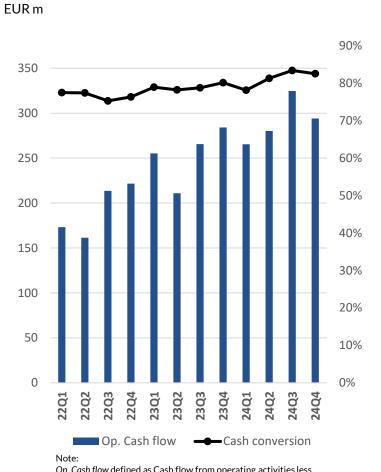
